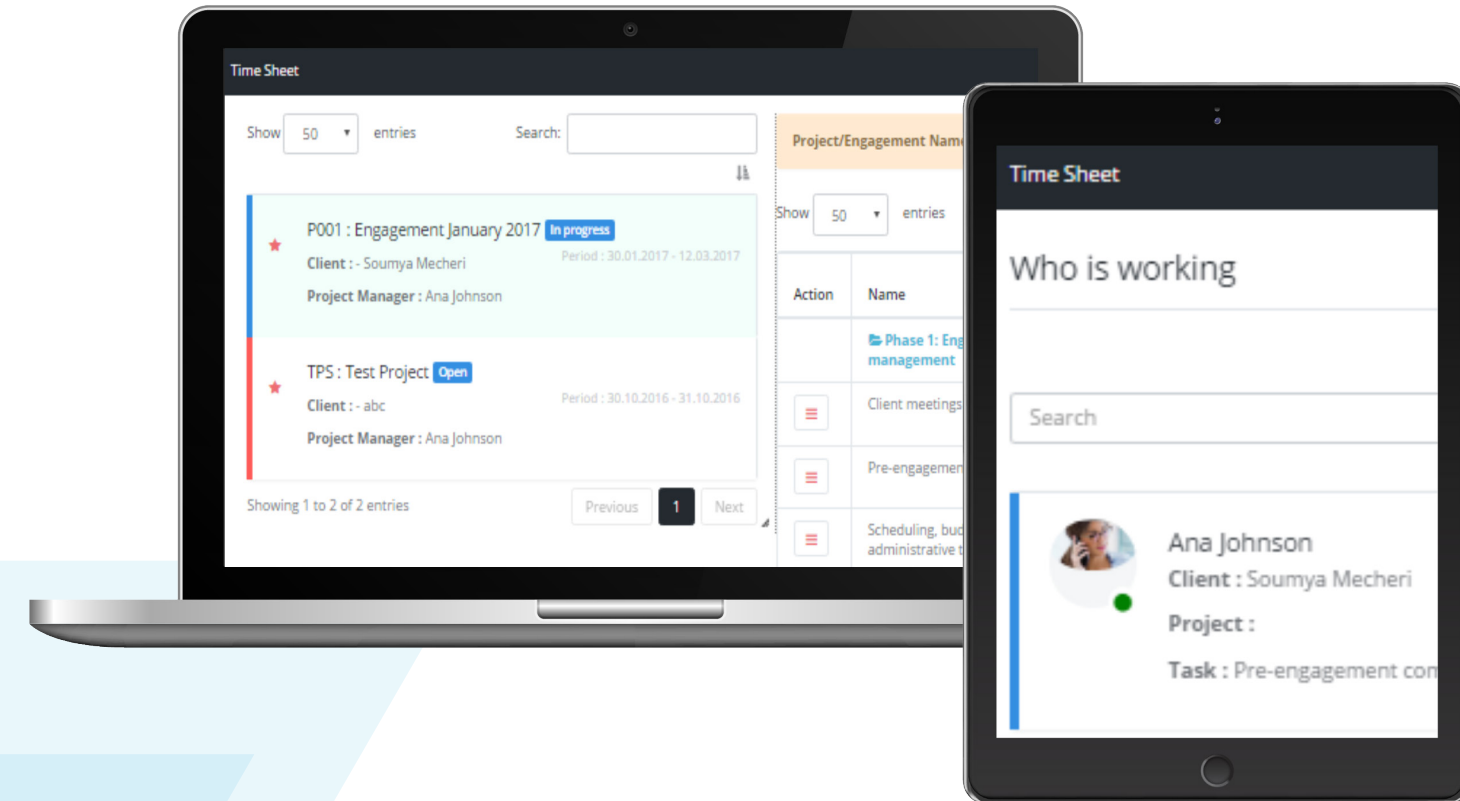


Timesheet

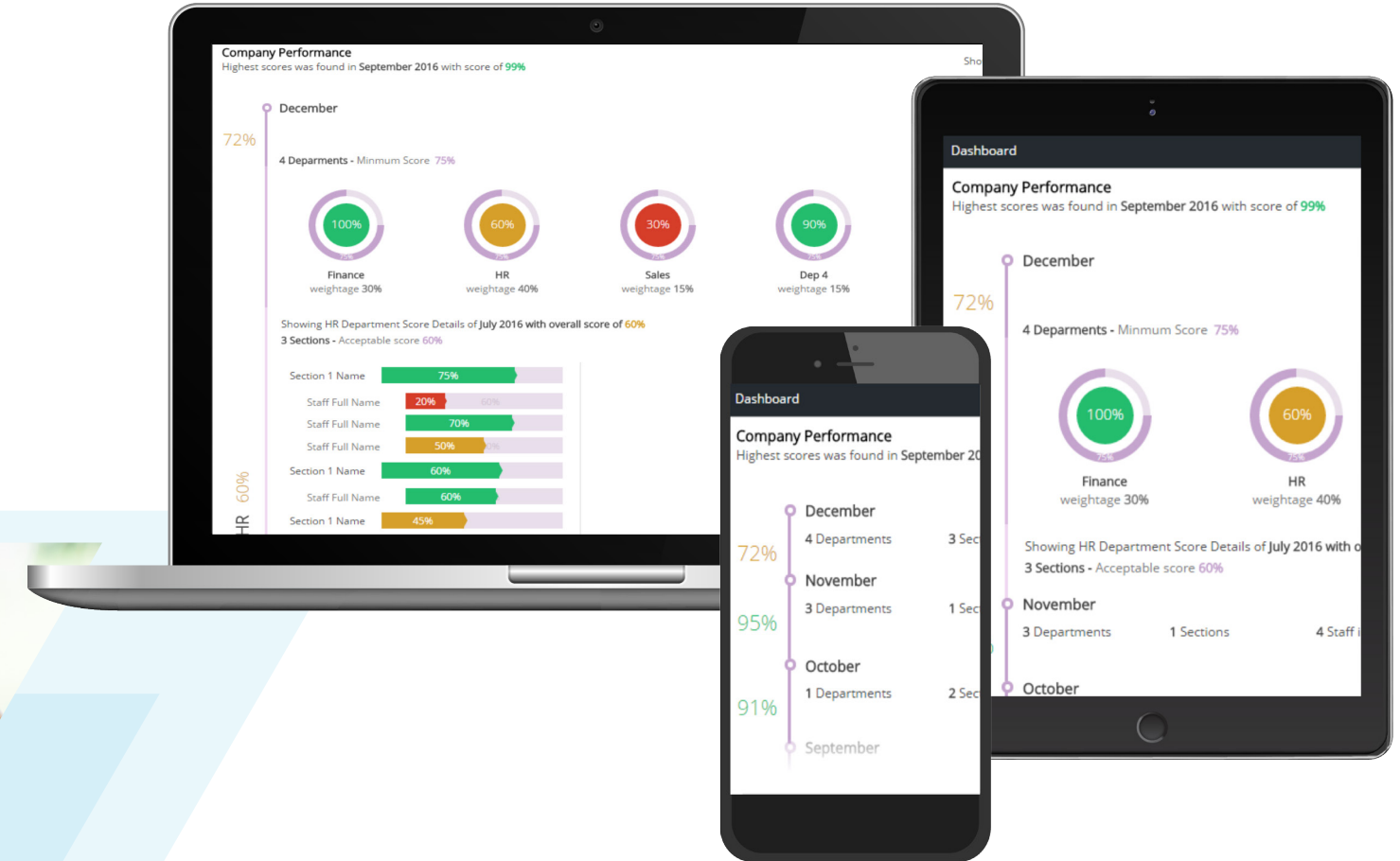
Company Performance

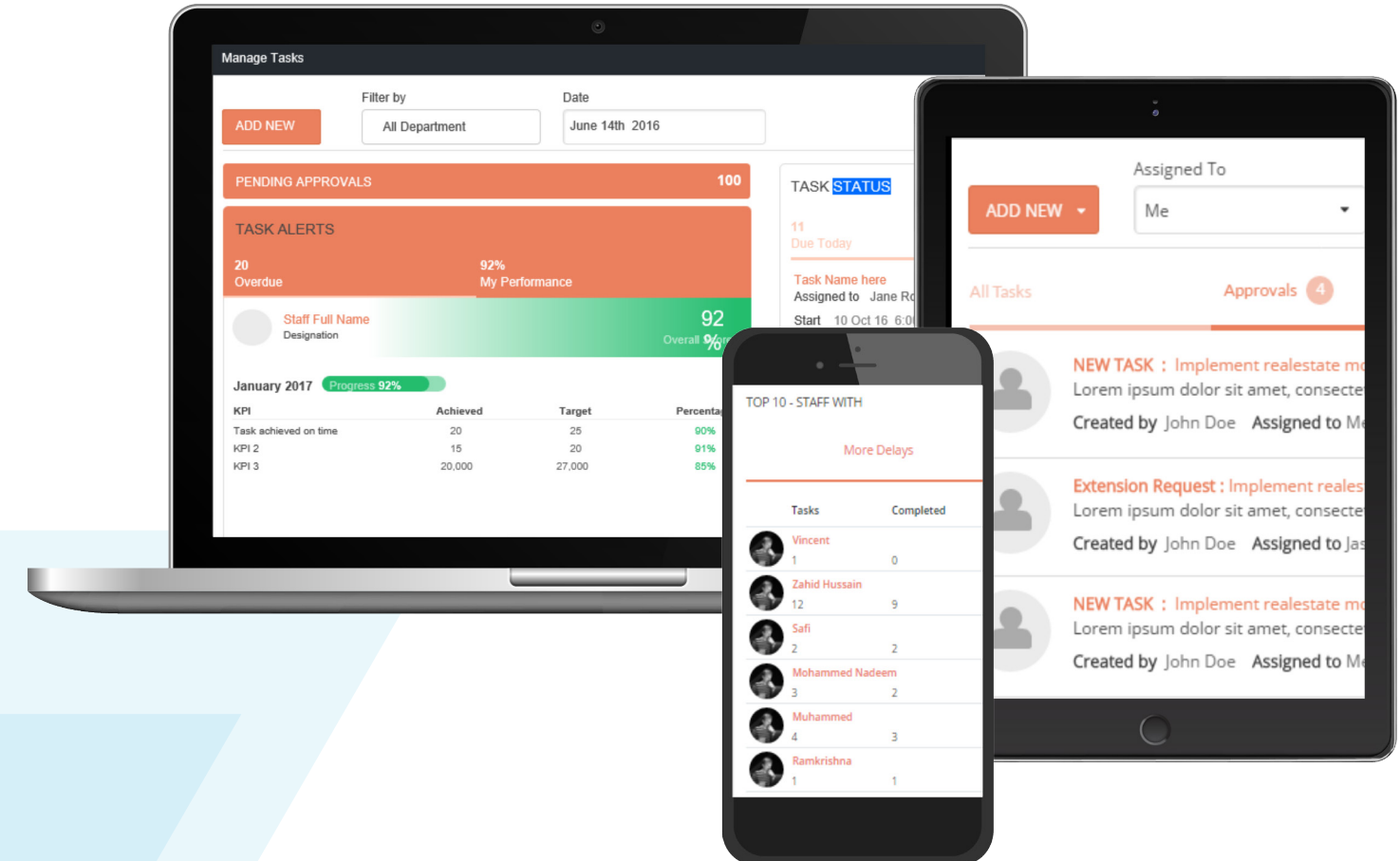


Task Management
